It is clear from the above facts that the Transferee Company had not complied with the provisions of section 233(1)(b) of the Companies Act, 2013 by not obtaining atleast 90% consents of the total value of shares held by the Transferee Company. Hence, the present application filed u/s. 233 of the CA, 2013 vide, e-form RD-1 vide SRN T24319527 dated 21.06.2021 is hereby rejected.
